(HEREINAFTER REFERRED TO AS THE "DOMESTIC SERVICES PROVIDER"),

COLLECTIVELY REFERRED TO AS THE "PARTIES," BOTH OF WHOM
AGREE TO BE BOUND BY THIS CONTRACT.

1. **PURPOSE.** THE CLIENT AGREES TO ADEQUATELY COMPENSATE THE DOMESTIC SERVICES PROVIDER TO PROVIDE DOMESTIC SERVICES AS REQUESTED BY THE CLIENT UPON COMPLETION OF SERVICE'S

2. **TERM.** THIS CONTRACT SHALL BE IN EFFECT UNTIL THE CLIENT NO LONGER REQUIRES THE DOMESTIC SERVICES PROVIDER TO ASSIST IN THEIR HOME OR UNTIL THE DOMESTIC SERVICES PROVIDER IS NO LONGER OFFERING SERVICES DUE TO EVER CHANGING CIRCUMSTANCES.

3. **SCHEDULE.** THE DOMESTIC SERVICES PROVIDER AGREES TO CONDUCT THEIR WORK AS REQUESTED IN THE CLIENT'S HOME. ALL WORKING TIMES MUST BE AGREED UPON BY BOTH PARTIES. A SCHEDULE CHANGE IS POSSIBLE IF THERE IS MUTUAL CONFIRMATION BY BOTH PARTIES.

4. **LOCATION.** THE DOMESTIC SERVICES PROVIDER WILL CONDUCT ALL REQUESTED DOMESTIC RELATED ACTIVITIES AT THE CLIENT'S RESIDENCE.

5. **CLIENT'S RESPONSIBILITIES.** THE CLIENT MUST PROVIDE FULL ACCESS TO THE PROPERTY WITHIN A SPECIFIED TIME. THE CLIENT AGREES TO REVIEW AND ABIDE BY ALL TERM AND CONDITIONS AS STATED ON THE WEBSITE: SIMPLEHEALTHNATURALLY.COM/TERMS
